## **CUSTOMER BILL OF RIGHTS**

As an individual receiving home health care equipment from Fonte Surgical Supply, Inc., let it be known that you have the following rights.

- 4. To be promptly informed if the prescribed care or services are not within the scope, mission, or philosophy of Fonte Surgical Supply, Inc., and therefore be provided with transfer assistance to an appropriate organization.
- 5. To be dealt with and treated with friendliness, courtesy and respect by each and every individual representing Fonte Surgical Supply, Inc., and be free from neglect or abuse be it physical or mental.
- 6. To have your privacy and your property respected at all times.
- 7. To assist in the development and planning of your equipment and supplies that will satisfy, as best as possible, your current needs.
- 8. To be provided with adequate information from which you can give your informed consent for the commencement of service, the continuation of service, the transfer of service, or the termination of service.
- 9. To express concerns or grievances or recommend modifications to your equipment and supplies without fear of discrimination or reprisal.
- 10. To receive products and services within the scope of your health care plan, promptly and professionally while being fully informed as to our policies, procedures and charges.
- 11. To refuse product, within the boundaries set by law, and receive professional information relative to the ramifications or consequences that will or may result due to such refusal.
- 12. To request and receive information regarding equipment, supplies and cost privately and with confidentiality.
- 13. To request and receive the opportunity to examine or review your medical records.
- 14. To expect that all information received by this organization shall be kept confidential and shall not be released without written consent.
- 15. To be involved in discussions and resolutions of conflicts and ethical issues related to your care.

#### **CUSTOMER RESPONSIBILITIES**

- 1. To notify Fonte Surgical Supply, Inc. prior to changing your residence or telephone number or insurance companies.
